GENERAL TERMS AND CONDITIONS OF SALE FOR NAUTICAL ACTIVITIES FOR INDIVIDUAL PARTICIPANTS

These general terms and conditions apply for the following activities:

- Courses: Sailing, kayak, surfing
- Beach Annex: Personal lessons, rentals, ...
- Training courses

REGISTRATION

- The registration will become definite upon acceptance by the Institut Sports Océan of the properly filled in and signed registration form.
- No registration will be considered without full payment.
- Discounts apply only at the moment of payment and may not be refunded at a later date.

MODIFICATIONS

- It is not possible to modify a reservation without prior consent of the Institut Sports Océan.
- Any request for modification (date, level, material) will be considered as a cancellation.
- The Institut Sports Océan may require a change of the participant's skill level group without entitling them to a refund.
- Only the services of the Beach Annex may be deferred to a later date within the limits of its planning possibilities. The validity of the units is limited to the current calendar year.

CANCELLATIONS

- A cancellation insurance will be proposed at the moment of course registration.
- When you take out this insurance policy your course fees will be reimbursed upon presentation of official documentary evidence stating medical reasons, a summoning to an examination, or a severe prejudice. The Institut Sports Océan will keep a fixed amount of € 20 per reservation.
- No refunds will be given after the beginning of the activity.
- The Institut Sports Océan may cancel a course, especially in the case of insufficient numbers of students or instructors.
- The Institut Sports Océan may suggest another activity at the same dates which the customer has the right to reject.
- If this is the case, The Institut Sports Océan will issue a full refund of the amount paid.
- Unfavorable weather or practicing conditions do not constitute a reason for cancellation. The activity will be altered or replaced accordingly without entitling the participant to a full or partial refund.

PRICES

The prices of our activities have been calculated according to the economic conditions existing at the moment of printing of our documentation.

Prices quoted in our documentation are not legally binding. The prices will be considered to be definite at the moment of registration.

Prices for all services exempted from V.A.T. are considered to be net prices.

Prices for all services liable for V.A.T. are considered to include all taxes.
